OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate income and some growth over the long term (5 years or more) by tracking the return of the JP Morgan GBI Global Index (Hedged to GBP). Performance Target: To match the return of the JP Morgan GBI Global Index (Hedged to GBP) (before charges). There is no certainty or promise that the Performance Target will be achieved.

JP Morgan GBI Global Index (Hedged to GBP) (the "Index") is a representative index of the global market for government bonds.

Investment Policy

Portfolio Securities

- The fund will invest at least 90% in government bonds (which are like loans to government that pay interest) that make up the Index.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.
- The Fund can invest 35% or more in bonds issued by a single government.

Management Process

- The management team aims to replicate performance of the Index in deciding which investments are to be included in the portfolio (passive management) and the number and weightings of investments may vary.
- Due to the nature of the passive management process, the fund's performance deviation from the Index is expected to be minimal.



What is this product?

Type: The Fund is a sub-fund of Institutional Cash Series plc, an umbrella company incorporated in Ireland, authorised by the Central Bank of Ireland as a Undertaking for Collective Investment in Transferable Securities ("UCITS").

Term: The Fund does not have a fixed term of existence or maturity period but in certain circumstances, as described in the Fund prospectus, the Fund may be unilaterally terminated following written notice to unitholders subject to compliance with the Fund prospectus and applicable regulation.

Objectives

- The Fund aims to maximise income on your investment consistent with maintaining capital and ensuring its underlying assets can easily be bought or sold (in normal market conditions). Money invested in the Fund is not protected or guaranteed.







What is this product?

Type

This product is a UCITS sub-fund of a variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended.

Term

This product has no fixed term.

Objectives

The fund aims to maximise the total return on your investment through primarily investing in a diversified portfolio of high yield fixed income instruments and securities that are denominated in major world currencies, using prudent investment management principles.

Investment Policy

The fund aims to achieve its objective by taking exposure to a diversified range of "high yield" fixed income securities and instruments (which are similar to loans that pay a fixed or variable rate of interest) issued by companies from around the world. The fund will mainly invest in "non-investment grade" securities. These are generally considered to be riskier investments than "investment grade" securities, but typically may produce a higher level of income.

The fund is considered to be actively managed in reference to the ICE BofAML BB-B Rated Developed Markets High Yield Constrained Index (the "Index") by virtue of the fact that the Index is used for duration measurement, calculating the global exposure of the fund using the

relative VaR methodology and for performance comparison purposes. Certain of the fund's securities may be components of and may have similar weightings to the Index. However, the Index is not used to define the portfolio composition of the fund or as a performance target and the fund may be wholly invested in securities which are not constituents of the Index.

Objectives

The fund aims to provide capital growth in excess of the MSCI All Countries World (Net Total Return) index (after fees have been deducted) over a three to five year period by investing in equities of companies worldwide which the investment manager classifies as sustainable. These are companies that, through the way they are managed and/or the goods and services that they sell, make a positive contribution to the Planet (the environment); and/or People (employee wellbeing; customer wellbeing; healthy, inclusive and connected communities; and/or effective and accountable institutions).

Investment policy

The fund is actively managed and invests at least 80% of its assets in equities of companies worldwide that focus on a range of equity factors (also commonly known as investment styles).
